RULES AND REGULATION RECREATIONAL VEHICLE PARK

Camping in the Recreational Park is governed by the Rules and Regulations listed below. These support the Covenant that govern the Park. We ask that you follow all of the Rules and Regulations out of respect for the community, all of its members, and the protection of the wildlife park we all enjoy. The Rules and Regulations are enforceable by law and will be strictly enforced. Financial reimbursement and fines will be used to ensure that our community maintains and follows the Covenants and Bylaws we are charged with following.

- ✓ **Agree to follow the Covenants.**
- ✓ Registration through the Forbes LOA office is required for each stay at the RV Park. All Campers, their families, guests, pets, and vehicles must be registered with the Forbes LOA Office. Reservations may be made through the Forbes LOA Office for the use of the Pavilion.
- ✓ **RV or Camper**/\$10 per night/per slip. **Tent**/\$5 per night/per slip.
- ✓ Must be paid at the time reservations are made.
- ✓ Cancellation of your reservation must be made 48 hours before your arrival date; noncompliance may result in a fine.
- ✓ There is a limit of 45 days per calendar year an owner can camp in the park, the maximum allowed stay for each visit is 14 days. After which time, the camp site must be vacated one week between stays.
- ✓ Maximum stays can be extended with Board approval.
- ✓ Vehicles are allowed only in designated areas. Do not block roadways.
- ✓ Parental supervision of children under the age of 18 is required at all times.

- ✓ Horses, pack animals, and pets are permitted in the park. All waste must be cleaned up and disposed of. All visiting animals must be on a leash/lead, and under the control of their owner at all times.
- ✓ Animals are not allowed in the Bathhouse.
- ✓ **Do not bring firewood in from other States.**
- ✓ ATVs are prohibited.
- ✓ Discharging firearms and fireworks are prohibited.
- ✓ Hunting, capturing, or harassing any of the wildlife is prohibited.
- ✓ Bikes are not allowed on the Tennis Courts.
- ✓ Use grills, fire rings, the bath house, restrooms, and the game courts for their intended purpose and properly.
- ✓ Fires are to be made and contained in the fire rings provided.
- ✓ All Camp Sites must be cleaned up, trash disposed of, and the site left in good condition for the next camper to use.
- ✓ The Forbes LOA Park Manager will inspect the RV Slip upon your departure. If you do not meet the obligation outlined above, you will be subject to a fine.
- ✓ You will be financially responsible for any damages to your RV Slip or the Forbes LOA RV Park property during your stay.
- ✓ Campers are responsible for monitoring the weather for warnings and watches.
- ✓ Do not leave your camper unattended. If you are going on a day trip, please notify the LOA Office with a date of departure and a return date.
